#### WHAT COMPETITION MANIPULATION IS?

Competition manipulation mean fraudulent influence match or competition course or the end result. generally take competition manipulation may share sports and betting-based manipulation. It manifests in different sports in different ways, for example as competition, match, instrument or result manipulation.

#### PROGRAM OBJECTIVE

The main objective of the European Convention is to prevent, identify and punish the manipulation of sporting competitions. Efforts are being made to develop cooperation between sports actors nationally and internationally in order to combat the manipulation of sports competitions. Objectives over aim at protect sport honesty and Ethics.

The aim of the Finnish Hockey Association's anti-competition manipulation programme is to influence, that all species actor understand, what omni nocte competition manipulation and that when detected, are familiar with the operating instructions related to its prevention.

Union training and communications measures Preventing Action aimed at competitive manipulation. The Federation's Board of Directors is responsible for ensuring that the Federation has sufficient human and/or other resources at its disposal to implement the programme and its measures.

#### CODE AND CONTRACT

The goal of the Hockey Association is to foster clean sport and to guarantee all its members the right to a fair and equal sport. In fair and clean sport, everything starts with respect: pure by means top aspirational athlete respect other athlete and common rules while at the same time nurturing their own well-being.

Finland Hockey Federation no acknowled doping Usage nor competitive manipulation in any form. this omni nocte registered Finland Hockey Federation operating rule and competition and disciplinary rules. Rules will be updated if necessary.

Penalty action is manipulations of the results and competition events and their attempts, as well as the failure of a sports operator to report known manipulations to the Federation, club or FINCIS. In addition, punishable activities omni nocte sports player Sharing inside information with outsiders. Inside information refers to information that is not known to those outside the club/team. Such information includes, for example, undisclosed assembly data, athletes' health conditions and competitive tactics.

### COMPETITION MANIPULATION SITUATIONAL/THREAT HOCKEY

Competition manipulation national threat assessment do FINCIS under the baton of two year at a time. FINCIS regularly updates the national situational picture, which also includes species-specific situational pictures and communicates this to the sport federations.

According to the situational picture published by FINCIS 2021, competitive manipulation in field hockey and its various sports forms threat omni nocte low. In species no be come quite Competition manipulation cases and the amount of betting, both nationally and internationally, are limited, and do not pose a significant threat to competition manipulation. Finnish sports clubs also do not involve significant private or international holdings or vague sponsors. There has been no suspicion that hockey is being used in criminal activities.

The Hockey Federation is preparing and taking the necessary measures to minimize the threats. The Federation is prepared for possible cases of manipulation and their handling. This competition manipulation security monitor aim is, that planned and effective measures are able to keep the risk to a minimum.

#### **EDUCATION**

The aim of the training activities is to ensure that everyone involved in the sport has up-to-date knowledge of competition manipulation and how to combat it, and that all those trained understand the dangers of competition manipulation, internalize the importance of the principle of fair play in sports and know approach see Referring to competitive manipulation author in sport. Training implement either in the context of events or as online training (fairly best training).



Competition manipulation and its anti- arrangement have also part Finland Hockey Federation sport and judge training. The main target groups of the trainings are judges, Athletes, Coaches. also government member and other key It is recommended that shop stewards participate in trainings and webinars organised by FINCIS for shop stewards.

Training activities responsible party Finland Hockey Federation work government the Chairman or a person specifically designated by the Board. The person in charge reports on the trainings held for FINCIS and monitors the implementation of the training obligations in the sports federation.

- 2. Tell about the proposal or possible violation to either the Federation of Finnish Sports, FINCIS or if desired directly police. Most relevant is, that tell pathreal reliable Go ahead, and you won't be alone with it. You can also Announce your information anonymous FINCIS Through the ILMO service https://ilmo.suek.fi.
- 3. Keep all the information you receive, such as text messages or emails sent to you. You can preserve information for example screen capture with the help of. They can later be used to investigate the case or as possible evidence.

#### OTHER ACTIVITIES

Finland Hockey Federation omni nocte fiduciary in various international organizations such as the EHF Board of Directors and Working Groups, where they contribute to the work against competitive manipulation.

#### PROGRAM MONITORING AND EVALUATION

The Board of the Finnish Hockey Association evaluates annually the implementation of the anti-competition manipulation programme musculi do annual plan action plan and by recording the measures taken in the annual report. The board of the union will also decide on updates to the program if necessary.
